What information we collect, use, and why

We collect or use the following information to **receive donations or funding and organise fundraising activities:**

- Names and contact details
- Addresses
- Payment or banking details
- Tax payer information (for Gift Aid purposes)

We collect or use the following personal information for **service updates or marketing purposes:**

- Names and contact details
- Addresses
- Marketing preferences
- Records of consent, where appropriate

We collect or use the following personal information for **recruitment purposes:**

- Contact details (eg name, address, telephone number or personal email address)

- Date of birth
- National Insurance number
- Copies of passports or other photo ID
- Employment history (eg job application, employment references or secondary employment)
- Education history (eg qualifications)
- Right to work information
- Details of any criminal convictions (eg Disclosure Barring Service (DBS), Access NI or Disclosure Scotland checks)
- Security clearance details (eg basic checks and higher security clearance)

We collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Address
- Purchase or service history
- Relevant information from previous investigations
- Information relating to health and safety (including incident investigation details and reports and accident book records)
- Correspondence

We also collect or use the following special category information for **dealing with queries, complaints or claims**. This information is subject to additional protection due to its sensitive nature:

We collect or use the following personal information for **To receive citizen science reports**:

- Names and contact details
- Addresses
- Photographs or video recordings

Lawful bases and data protection rights

- **Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for. [Read more about the right of access.](#)

Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information to **receive donations or funding and organise fundraising activities** are:

except the right to object. To be clear, you do have the right to withdraw your consent at any time.

- Legitimate interests – we’re collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - Enabling us to keep donors up to date with new projects and the outcome of projects they have donated to, if they consent to this. It enables the foundation to strengthen relationships with donors, and enables donors to feel connected to the work they are supporting.

Our lawful bases for collecting or using personal information for **recruitment purposes** are:

- Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Contract – we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.
- Legal obligation – we have to collect or use your information so we can comply with the law. All of your data protection rights may apply, except the right to erasure, the right to object and the right to data portability.

Our lawful bases for collecting or using personal information for **dealing with queries, complaints or claims** are:

 - It enables us to log sightings of rare species and contact the reporter to provide further information about the individual/s they identified

Where we get personal information from

- Directly from you

How long we keep information

- Personal data will be retained only for as long as necessary.
- Standard retention periods:
 - Financial records – **7 years** (HMRC requirement)
 - Staff records – **6 years** after leaving
 - Donor and supporter contact details – reviewed every **2 years**
 - Incident/accident reports – **10 years** minimum
- When data is no longer required, it will be **securely deleted or shredded**.

How to complain
